

GoodData Referral Program

GoodData s.r.o., as the announcer ("GoodData"), is constantly looking for new employees, and prefers to recruit persons recommended by its employees or the professional public. Therefore, GoodData is announcing a reward for anyone who recommends a good employee ("Candidate") under the specific terms and conditions set forth herein.

GoodData undertakes that each individual ("Recipient") who:

a. is neither:

- a person who carries out business in human resources, nor
- a recruiting agency ("Agency"), or a person cooperating with an Agency in any other capacity, nor
- an employee of GoodData explicitly excluded from the GoodData Referral Program:
 - GoodData executive at VP and C level;
 - GoodData recruiter, HR Director or other HR employee participating directly in recruitment processes in GoodData; nor
 - · a potential direct manager/supervisor of the Candidate;

b. and recommends to GoodData a Candidate:

- for a concrete open position located in the Czech Republic (Prague/Brno);
- who is not already in GoodData's applicant database, and is not active in the recruitment process – in which case the Recipient will be informed by GoodData;

The Recipient becomes entitled to the reward after the Candidate's trial period passes. GoodData will issue a protocol confirming the reward payout. Reward payment is based on the Recipient signing the protocol. It is payable within thirty (30) days from the date of the protocol signature by bank transfer to the account specified in the protocol. Please note that the reward is subject to the applicable taxes. The Recipient receiving the reward is solely responsible for any tax obligations related thereto (such as tax return, etc.).

One Recipient may recommend more than one Candidate. If one Candidate is recommended by more than one Recipient for the same open position, the reward will be provided to the Recipient who recommended the Candidate first for that specific open position.
